designated dates, or in the event of damaged or impe	erfect film or equipment, The owner agrees to the b	est of the owner's ability
to accommodate [NAME] in granting the right to use	the premises at a later date to be mutually agreed	upon. This grant of location
rights is in connection with the motion picture photo	play tentatively entitled [], a	nd includes the right to re-
use the photography in connection with other motion picture photoplays as you, your successors, assigns and licensees shall elect,		
and, in connection with the exhibition, promotion, advertising and exploitation thereof, in any manner whatsoever and at any time		
and in any part of the world. Similarly, [NAME] agrees to hold the owner free from any claims for liability, damage or injury arising		
during occupancy of the premises and arising out of	your negligence thereon on the aforementioned dat	es; [NAME] further agrees
to leave the premises in as good order and condition	as when received, excepting reasonable wear, tear,	force majeure, and use. The
owner acknowledges that, in photographing the prer	nises, [NAME] is not in any away depicting or portra	ying the owner in the motion
picture photoplay, either directly or indirectly. The ov	wner guarantees hereto that he will not assert or m	aintain against [NAME] any
claim of any kind or nature whatsoever, including, an	d without limitation, those based upon invasion of p	privacy or other civil rights,
defamation, slander or libel, in connection with the exercise of the permission herein granted. Further, the owner represents that he/		
she/they is/are the actual and legal owner(s) and/or authorized representative(s) of the premises, and thereby has the authority to		
grant to [NAME] by pen the permission and rights he	erein specified, and that the permission of no other p	party is required.
